

High Quantity Seizures by NCB (Zone wise)

Ahmedabad Zone

- On 06.04.2022, NCB, Ahmedabad Zonal Unit seized 168 grams of Mephedrone at Mehsana, Gujarat. 01 person was arrested.
- On 08.04.2022, NCB, Ahmedabad Zonal Unit seized 150.350 kg of Poppy Straw at Kheda, Gujarat. 03 persons were arrested.
- On 18.04.2022, NCB, Ahmedabad Zonal Unit seized 3.100 kg of Opium

at DHL Courier,

Ahmedabad.

- On NCB, Ahmedabad Zonal Unit seized 1 012 kg of Methamphetamine at DHL Courier, Ahmedabad.
- On 04.06.2022, NCB, Ahmedabad Zonal Unit seized 68,226 kg of Alprazolam at Vapi, Valsad, Gujarat. 04 persons were arrested.



On 09.06.2022, NCB, Ahmedabad Zonal Unit seized 523.450 kg of Ganja at Lindiyat, Surat, Gujarat. 03 persons were arrested.





- On 15.06.2022, NCB, Ahmedabad Zonal Unit seized 724.400 kg of Ganja at Lazore Circle, Surat. 07 persons were arrested.
- On 18.06.2022, NCB, Ahmedabad Zonal Unit seized 352.520 kg of Ganja at Chouryasi Toll Plaza, Surat. 03 persons were arrested.





Case Study

Seizure of 68.226 kg of Alprazolam by NCB Ahamedabad Zone

On 04.06.2022, acting on specific information, a team of NCB, Ahmedabad conducted raid at Parshvanath Dyechem, III Phase, GIDC Vapi, Valsad, Gujarat resulting in seizure of 68.226 kg of Alprazolam and arrested 04 persons. The premises was being used for manufacturing Alprazolem/Nordazepam/Psychotropic substances illegally without any license (as required). As told by the 04 accused, the raw material used for manufacturing of contraband was stored at a godown nearby (III phase, GIDC, Vapi). The said godown was searched and various chemicals in bulk quantity were found stored there. The premises / factory and godown alongwith apparatus inventory (75.490 Kg Alprazolam / Nordazepam / Psychotropic substance) and various chemicals were seized.





Bangalore Zone & Hyderabad Sub Zone

- On 14.04.2022, NCB, Bangalore Zonal Unit seized 3.176 kg of Hashish at Yeshwanthpur Railway Station, Bangalore. 03 persons were arrested.
- On 07.05.2022, NCB, Bangalore Zonal Unit seized 357 grams of Clonazepam Tablets at DHL Express (India) Pvt. Ltd, Kempegowda International Airport, Bangalore.
- On 24.05.2022, NCB, Bangalore Zonal Unit seized 13.850 kg of Heroin at Surya Residency, New Airport Road, Bangalore. 08 persons were arrested.

Case Study

Seizure of 13.850 kg of Heroin by NCB Bangalore Zone

On 24.05.2022, acting on input from NCB Hgrs, the NCB, Bengaluru attempted a controlled delivery and affected a seizure of 7 kg heroin concealed in bottom of a bag coming from Nairobi by flight at Bengaluru Airport. A lady receiver (Accused1) was apprehended and during spot interrogation she revealed about another lady (A2), who was waiting in airport parking area for taking delivery of the contraband was also apprehended. She was supposed to carry the seized contraband to Delhi by train for further delivering it to an African national.

Both the ladies were interrogated thoroughly and technical intelligence analysis was carried out. During which they revealed that one similar bag was kept in the lodge where they were staying and immediately the search of room resulted in the recovery of similar type of bag and 6.850 kgs. of Heroin.

In the technical analysis, it came to light that 03 more lady passengers with similar consignment have boarded Rajdhani Express from Bengaluru to Delhi. The details of ticket and names was shared with Operation section and Indore Zonal Unit for interception at Bhopal. But these three ladies got off the train a station before at Itarsi railway station. Immediately NCB Bengaluru again worked on the technical intelligence and narrowed down limit of the carriers. The said input was shared with Indore team who apprehended the three ladies from a lodge and recovered 21 kgs. of Heroin from three trolley bags.

Simultaneously the handlers of these girls were identified and found that they were flying from Delhi to Bengaluru. The NCB Bengaluru intercepted both the handlers (A3) and (A4) at Bengaluru airport in the evening of same day. Their interrogation revealed about the lead & details of some African handlers in Delhi.

Further the lady handler (A4) who opted to cooperate with NCB in identifying and nabbing the African national at Delhi, an team along with her was immediately flown to Delhi and attempt was made to nab African handler at Delhi with help of Ops team. The said lady handler revealed more information about many such modules operating at Delhi.

On NCB Bengaluru lead one Nigerian male (A5), who was kingpin in Heroin racket and three more lady Nigerian associates (A6, A7 and A8), who came to receive the



contraband were apprehended by Ops team at Delhi on 26.05.2022 and were summoned to Bengaluru for further interrogation and arrested.

NCB Bengaluru had successfully busted and neutralized the entire syndicate. In this operation with seizure of 35 kg Heroin (approx.), apprehended one Nigerian kingpin, 02 handlers from North East and 05 carriers and Rs 5.80/- lakh as drug money from the handler from Mizoram.

Further, during investigation of this case one more associate of (A4) was intercepted at Uttamnagar, New Delhi (A9) with directions from NCB Hq, Ops section and was summoned at Bengaluru and placed under arrest for involvement in Heroin trafficking from African countries to India.

The lab report has answered positive for Heroin. All accused are in judicial custody. Investigation is in progress in this case.

Case Study

1.) Seizure of 14.700 kg of Opium by NCB Chandigarh Zone

On 26.05.2022, Superintendent NCB, Chandigarh directed a team to work-out on the information of one car bearing Punjab's registration number in which 02 persons were coming along with huge quantity of Opium and were about to pass through Shambhu Toll Plaza, Ambala on 26.05.2022 afternoon. Thereafter, surveillance was mounted and the car was intercepted at Shambu barrier, Ambala. Search and seizure proceedings were conducted at the spot and 14.700 kgs Opium was seized. After the Panchanama Proceedings, Accused-1 (Age-58 years) r/o Amritsar, Punjab, A-2 (age-34 years) R/o Tran Taran, Punjab & A-3 (Mother of A-2, age-68 years) R/o Tran Taran, Punjab were served with the Notices under section 67 of the NDPS Act, 1985 to tender their voluntary statement. According to the confession made in the voluntary statements of all three apprehended persons, they were put under arrest on 27.05.2022. After medical examination, all the accused persons were produced before the Hon'ble duty magistrate Ambala. Accordingly lady accused was sent into judicial remand and other two accused were taken into 02 days NCB custody.

On the other hand about 52 grams opium and INR. 2,00,000/-(two lakh) were seized during house search of the A-3 and A-2 (mother & son).









2.) Seizure of 03.870 kg of Heroin by NCB Amritsar Sub-Zone

On 29.05.2022, the troops of BOP- Ghoga, 183-Bn BSF, Punjab have recovered 02 metallic cylinders and 08 bricks having Concealment of the suspected Narcotics contraband. The Modus Operandi to conceal the contraband is different from the previously existing patterns.

The recovered packets were handed over to NCB, Amritsar by Bop - Ghoga 183-Bn BSF, for further legal proceedings as per law. A Crime Case was registered U/s- 08, 21 & 23 of NDPS Act against unknown. Total weight of suspected Narcotics (Heroin) was 03.870 Kg. The seized case property was produced in Ajnala for procedure U/s-52-A and taking out the samples from the bulk case property.



Chennai Zone, Madurai Sub Zone & Kochin Sub Zone








Case Study

1). Seizure of 34.250 kg of Heroin by NCB Delhi Zone

On 26.04.2022, based on specific information, NCB, Delhi Zonal Unit seized 01 Kg Heroin from the possession of a person travelling in a Haryana number vehicle & based on further investigation 34.250 Kg Heroin, 3.650 Kg suspected Psychotropic Substances and 2.75 kg of Acetic Anhydride were seized from Go-down at NH 58, near Jaroda village Bus Stand, Sarwasti Vihar colony, Muzaffar Nagar, U.P. During the followup, seven other persons were also arrested. This case involved import of unfinished heroin from Iran/Afghanistan which was then processed by the syndicate members and was being sold locally/inter-state. Further investigation is in progress.

2). Seizure of 50 kg of Heroin by NCB Delhi Zone

On 27.04.2022, based on specific information, NCB, Delhi Zonal Unit seized 50 Kgs heroin, 47.06 Kgs suspected Narcotic Drugs/Psychotropic Substances, Rs. 30 Lakh (Indian currency - denominations 500) and other articles from the rented premise of a person at Jamia Nagar, Okhla, New Delhi. During the follow-up, eight other persons were also arrested. The syndicate was involved in importing unfinis

Guwahati Zone & Imphal Sub Zone

- On 05.04.2022, NCB, Guwahati Zonal Unit seized 4601.780 kg of Ganja at Balagaon, Rangia, Kamrup, Assam. 02 persons were arrested.
- On 10.04.2022, NCB Guwahati Zonal Unit seized 1.045 Kg of Heroin at Guwahati Railway Station near the office of RPF. 02 persons were arrested hed heroin and processing the same and sale of heroin locally and inter-state.



- On 06.05.2022, NCB, Imphal Sub-Zone seized 915 grams of Heroin at Sankumai, Senapati, Manipur. 02 persons were arrested.
- On 09.05.2022, NCB, Guwahati Zonal Unit seized 30,279 bottles of Codeine based cough syrup at Amingaon Flyover, Kamrup, Assam. 02 persons were arrested.
- On 29.05.2022, NCB, Imphal Sub-Zone seized 825 grams of Heroin at Churachandpur, Manipur. 01 person was arrested.





- On 01.06.2022, NCB, Imphal Sub-Zone seized 6.654 kg of Heroin at Churachandpur, Manipur. 01 person was arrested.
- On 02.06.2022, NCB, Imphal Sub-Zone seized 1191.200 kg of Ganja at Tadubi, Senapati district, Manipur. 01 person was arrested.
- On 02.06.2022, NCB, Guwahati Zonal Unit seized 16.777 kg of Heroin at Baihata Chariali, Kamrup (R), Assam. 02 persons were arrested.
- On 13.06.2022, NCB, Guwahati Zonal Unit seized 289 grams of Heroin at Guwahati Railway Station, Assam. 01 person was arrested.





On 22.06.2022, NCB, Guwahati Zonal Unit seized 1,484.950 kg of Ganja from a truck at Guwahati. 02 persons were arrested.



Case Study:

1). Seizure of 4601.78 kg of Ganja by NCB Guwahati Zone

On 05.04.2022, NCB Guwahati Zonal Unit affected a seizure of 4601.78 kg ganja from a truck bearing Nagaland registration number at NH-31, Balagaon, Rangia, Kamrup (Rural), Assam, One person r/o Sigrahata, District- Bhoipur, Bihar was apprehended along with the alleged Ganja and served with notice u/s 67 of NDPS Act, 1985 to tender his voluntary statement. On the basis of recovery and his confessional statements he was arrested on 06.04.2022 for violation of section 8 (c) punishable U/s 20 (b) (ii) (c) of the NDPS Act, 1985 (as amended). During the statement, arrested accused revealed that one associate carrier had left by train from Agartala, Tripura for Siliguri, West Bengal after departure of the seized loaded truck to escape from

interception by law agencies enroute and informed the carrier that he would accompany him again in Siliguri. However, NCB team received an information that due to the fact that the seized loaded truck not arriving at Siliguri in scheduled time, the accused deboarded from the train and as per direction of Owner of the seized truck and returned back to Guwahati and went to the sopt at Guwahati in search of the truck from where he was apprehended by NCB Guwahati and later arrested.







2.) Seizure of 30,279 Bottles Codeine Based Cough Syrup (CBCS, Phensedyl) by NCB Guwahati Zone

On 09.05.2022, NCB Guwahati Zonal Unit intercepted a TATA Truck bearing registration no. of Assam near Amingaon flyover, NH no. 27, District Kamrup (Rural), Assam and further affected a seizure of 30,279 Bottles CBCS Phensedyl from the Truck at NCB Guwahati Zonal Unit office, Guwahati, Assam. Two persons were apprehended, both R/o Distt - Karimgani, Assam. On the basis of recovery of the said CBCS Phensedyl and their voluntary confessional statements U/s 67 of NDPS Act, 1985, both of them were arrested on 10.05.2022 for violation of Sec 8 (c) punishable U/s 21 (C) and 29 of NDPS Act, 1985.







3.) Seizure of 16.777 kg of Heroin by NCB Guwahati Zone

On 02.06.2022, NCB Guwahati Zonal Unit affected a seizure of 16.777 kgs. of Heroin from a Maruti Gypsy bearing reg. no. of Assam. Two persons were arrested, one of them was Permanent R/o Distt-Samastipur, Bihar (present R/o Ulubari, PS-Paltan Bazar, Kamrup (M) Guwahati, Assam) and other person was R/o- Pachim Majdia, PS-Sonatari, Dist.- Barpeta, Assam. On the basis of recovery of the said Heroin and their voluntary confessional statements U/s 67 of NDPS Act, 1985, both of them were arrested on 03.06.2022 for violation of section 8 (c) punishable U/s 21 (c) and 29 of NDPS Act, 1985.





4.) Seizure of 1484.95 kg of Ganja by NCB Guwahati Zone

On 22,06,2022, NCB Guwahati Zonal Unit affected a seizure of 1484,95 kg Ganja from a truck bearing reg. no. of Uttar Pradesh. Two persons were apprehended, both R/o Amroha, Distt. – Jvotiba Phule Nagar, Uttar Pradesh, On the basis of recovery of the said Ganja and their voluntary confessional statements U/s 67 of NDPS Act, 1985, both of them were arrested on 22.06.2022 for violation of Sec 8 (c) punishable U/s 20(b)(ii)(C) and 29 of NDPS Act, 1985.

All the accused arrested in this case are lodged in District Jail Ambphalla, Jammu. Further investigation in this case is under process.

1.) Seizure of 2,182.410 kg of Poppy Straw by NCB Jodhpur Zone

On 01.05.2022, based on specific information, Team of NCB Jodhpur Zonal Unit intercepted and searched the vehicle/Truck at Manoharpur toll plaza, Jaipur and during search, recovered 71 white colour plastic bags & jute bags having concealment of poppy straw weighing 2,182.410 kg and arrested one person in contravention of section 8, 15, 25 and 29 of NDPS Act, 1985, on 02.05.2022

Case Property and the accused were produced in the Hon'ble NDPS Court, Jaipur. Accordingly, on 04.05.2022 the accused was sent to Judicial Custody, whereas proceedings of 52 A of case property was conducted in the concerned Hon'ble Court. At present case is under investigation.





2). Seizure of 203.190 kg of Poppy Straw by NCB Jodhpur

On 18.05.2022, based on specific information, Team of NCB Jodhpur Zonal Unit intercepted and searched the vehicle i.e., Brezza bearing Rajasthan number at at Bhilwara, Rajasthan and during search, recovered 10 black colour plastic bags having concealment of poppy straw weighing 203.190 kg and arrested two persons after recording their statements under Section 67 of the Act and in contravention of section 8, 15, 25 and 29 of NDPS Act, 1985, on 19.05.2022



Case Property and both the accused were produced in the Hon'ble Court and further sent to Judicial Custody on 20.05.2022, whereas proceedings u/s 52 A of case property were conducted in the concerned Hon'ble Court. At present case is under Investigation.



3.) Seizure of 4.494 Kg of Opium by NCB Jodhpur Zone

On 28.05.2022, based on specific information, Team of NCB Jodhpur Zonal Unit seized 4.494 Kg Opium from a car at Nawali Gate Bus stand, Nokha, Bikaner and apprehended two persons. Out of these two person, one was carrier who brought the consignment of Opium and other person was receiver who came by Car (Maurti Alto, Rajasthan number) to receive the consignment of Opium.

After completion of seizure proceedings, statements of both the accused were recorded under Section 67 of NDPS Act and for contravention of section 8, 18, 25 and 29 of NDPS Act, 1985, both the persons were arrested.

The source of drug was Nagaland and destined to Nokha, Bikaner. In the said case, both carrier and receiver were arrested. A inter-state trafficking netwok is emeraed.

Case Property and both the accused were produced in the Hon'ble Court, Nokha on 29.05.2022. Both the accused were sent to Judicial Custody after completing remand period. Whereas, proceedings u/s 52 A for the case property was conducted in the concerned Hon'ble Court. At present case is under investigation.



On 07.06.2022, acting upon specific information, NCB Kolkata Zonal Unit seized 20000 bottles of Phensedyl cough linctus containing codeine phosphate from a 6 wheeler vehicle bearing UP registration no. at Berhampore- Islampur Road 6 Kms approx before Islampur and arrested two persons. And produced before Berhampur Court on 08.06.2022. Sampling and certification under 52(A) has been done on 08.06.2022 & 09.06.2022 respectively. Letter was issued to manufacturer of the Phensedyl cough linctus Abbott Healthcare Pvt. Ltd., and further reply was received; accordingly letter was sent to GR Trading for further details, which further submitted the list of 26 firms to which GR Trading supplied. Letter was also sent to all the 26 firms but reply is still awaited. At present case is under investigation.



2.) Seizure of 1582 Kg of Ganja by NCB Kolkata Zone

On 11.06.2022, on the basis of specific intelligence input and further developed by the NCB Team on ground, NCB Kolkata Zonal Unit seized 1582 Kg greenish coloured flowering top of cannabis plants believed to be Gania containing in 87 nos, plastic sacks from the house premises of the an accused R/O Sitalkuchi, Cooch Behar, West Bengal, registered a crime case and further arrested him. During the operation, the officials of BSF participated with NCB Team.

The entire search and seizure procedure was conducted on the spot in the presence of 02 independent witnesses. The accused person along with seized contraband was produced before the Hon'ble Court at Coochbehar on 13.06.2022. Sampling was done before the Hon'ble Court and certification u/s 52 (A) was also completed on 16.06.2022. At present case is under investigation.

Angul, Odisha for trafficking of contraband.

Interrogation from the truck driver revealed that the truck was loaded with round shaped aluminum sheets in Angul, Odisha and the contraband was concealed in between these sheets. The driver, further, told that he was directed to unload the contraband at Mathura, U.P. The investigation at the receiver's end is still going on.





2.) Seizure of 14352 nos. of Tramadol capsules (Total 8.6 Kilograms) by NCB Lucknow Zone

On 15.06.2022, Acting upon a specific information of a person R/o Varansi (UP), a team of NCB Lucknow Zonal Unit raided the godown at Jagatgani, Varansi (UP) and seized 14352 nos. of Tramadol capsules (Total 8.6 Kilograms). The Tramadol capsules were kept in dusty carton boxes and it was clearly indicative that these boxes were meant for illicit diversion. During the investigation, it was found that the accused is already behind bars in Patna Jail in one of NCB, Patna Zonal Unit case. The investigation in this case is under progress.

Further, during follow up action, consignor & courier agent were intercepted by NCB, Mumbai. During preliminary interrogation, it is found that courier franchise owner is also involved in drug trafficking. The courier agent send parcel without verification of identity of consignor and also send parcel for many times on the instructions of main receiver.

Fake identity was used by the consignor to ship the parcel through courier. This network has sent many such types of parcels in the past. The kingpin had created layers in the delivery network. Further investigation is under progress.

Narco-coordination Centre (NCORD) mechanism:

On 05.05.2022, 4th meeting of the Apex level Committee of NCORD (Narco Coordination Centre) was held at North Block, MHA which was presided over by the Hon'ble Union Home Secretary Sh. Ajay Bhalla. Officials of NCB and officers from various Central Ministrits / Departments / Agencies participated in offline mode. In addition to the above, Chief Secretaries of all States/UTs and Director General of Police or their representatives participated in the meeting in virtual mode.

Agenda Points proposed by MHA, NCB and MoSJE:

- Review of actions taken on the decisions taken in 3rd Apex Committee Meeting held on 27.12.2021.
- Drug trafficking through maritime routes and various measures for its containment.
- Development of effective mechanism for destruction of illicit cultivation of Opium and Cannabis.

Hon'ble Union Home Secretary stated that the menace of drug abuse is a matter of serious concern which needs coordinated action of all Departments/Ministries and drug law enforcement agencies to fulfill the vision of Hon'ble Prime Minister of "Nasha Mukt Bharat". Some of the major decisions taken during the meeting are as under:

- Pending issues related to the directions given during 3rd Apex NCORD needs proper attention by the states and Chief Secretaries were requested to review the status in their respective State NCORD meetings for better implementation and improved results.
- It was emphasized that there is a need to review Notification dated 16.01.2015 issued by DoR with regards to disposal of seized drugs by taking into cognizance the views and suggestions of different stakeholders and also the directions issued by the Hon'ble Supreme Court and other High Courts in the matter.
- Concerned authorities dealing with coastal security like Indian Navy, Indian Coast Guard and Port Authorities with active participation of DLEAs should form a 'Special Study Group' to handle drug trafficking through maritime route and to examine the possibility of using drones for surveillance.
- It was proposed that DoR may make suitable amendments in rules, if required regarding destruction of illicit cultivation of Opium/Cannabis as well as to provide alternate livelihood source for the farmers involved especially in those area, where such cultivation is part of tradition.



On 15.06.2022, the 21st Monthly meeting of NCORD under the chairmanship of DG, NCB was held through video conferencing mode covering the different issues related to drug trafficking, particularly pertaining to the Eastern states. Representatives from States of Bihar, Jharkhand, Odisha and West Bengal participated in this meeting apart from the regular members of monthly NCORD.





ब्यूरो मुख्यालय व इसके क्षेत्रीय कार्यालयों की वार्षिक मूल्यांकन रिपोर्ट संकलित करके मुख्यालय एवं क्षेत्रवार "क", "ख" व "ग" की कुल चार रिपोर्टें तैयार करके महानिदेशक महोदय के अनुमोदन से गृह मंत्रालय को भिजवाई गई।

हिंदी कार्यशाला का आयोजन

स्वापक नियंत्रण ब्यूरो, मुख्यालय में दिनांक 15 जून, 2022 को "कार्यालयी कार्यों में हिंदी भाषा का व्यावहारिक प्रयोग तथा राजभाषा संबंधी दिशा-निर्देश" विषय पर हिंदी कार्यशाला आयोजित की गई। इस कार्यशाला के दौरान श्रीमती किरण भारद्वाज, संयुक्त निदेशक (रा.भा.) (सेवानिवृत्त), स्वास्थ्य मंत्रालय द्वारा व्याख्यान दिया गया। इस कार्यशाला में ब्यूरो से कुल 13 अधिकारियों ध्कर्मचारियों भाग लेकर इस विषय के संबंध में महत्वपूर्ण जानकारी प्राप्त की। दिल्ली क्षेत्रीय इकाई के कार्मिकों द्वारा भी इस कार्यशाला में भाग लिया गया।

ब्यूरो की गृह पत्रिका नारकंट्रोल हेतू हिंदी भाषा में लेख सामग्री

ब्यूरो की गृह पत्रिका नारकंट्रोल हेत् महानिदेशक महोदय के निदेशानुसार मुख्यालय एवं सभी क्षेत्रीय एवं उप- क्षेत्रीय कार्यालयों आदि से हिंदी भाषा में लेख इत्यादि आमंत्रित किए गए ताकि पत्रिका में हिंदी भाषा की लेख सामग्री भी शामिल की जा सके। इसके लिए तीन सर्वश्रेष्ठ लेखों हेतू महानिदेशक महोदय द्वारा निर्धारित प्रथम, द्वितीय व तृतीय क्रमशः 5000 रु., 4000 रु. व 3000 रु. के नकद पुरस्कार प्रदान किए जा रहे हैं।

वार्षिक कार्यक्रम

राजभाषा विभाग, गृह मंत्रालय द्वारा जारी वार्षिक कार्यक्रम— 2022—2023 को ब्यूरो मुख्यालय व इसके अधीनस्थ क्षेत्रीय एवं उप क्षेत्रीय कार्यालयों में परिचालित किया गया जिससे कि वार्षिक कार्यक्रम में उल्लिखित निर्धारित लक्ष्यों को समुचित रूप से प्राप्त करने के लिए यथोचित प्रयास किए जा सकें।

जांच बिंद्

महानिदेशक महोदय की ओर से ब्यूरो मुख्यालय में राजभाषा नीति का अनुपालन सुनिश्चित करने के लिए जांच-बिंदू (बिमबा च्वपदजे) निर्धारित किए गए। राजभाषा नियम, 1976 के नियम-12 के प्रावधान के अनुसार, स्वापक नियंत्रण ब्यूरो में राजभाषा हिंदी के प्रगामी प्रयोग तथा राजभाषा अधिनियम, 1963 और उसके अधीन बनाए गए नियमों के अनुबंधों तथा केंद्रीय सरकार द्वारा इस बारे में जारी किए गए निदेशों का समृचित रूप से अनुपालन सुनिश्चित करने के लिए जांच-बिंदु निर्धारित करते हुए इनके अनुपालन का दायित्वों का निर्वहन करने हेतु संबंधित अधिकारियों प्रेषित किए गए तथा साथ ही, ब्यूरो के क्षेत्रीय व उप क्षेत्रीय कार्यालयों को भी इसी प्रकार जांच बिंदू निर्धारित किए जाने के निर्देश दिए गए।

स्वापक नियंत्रण ब्यूरो के हिंदी-अंग्रेजी अनुवाद संबंधी महत्वपूर्ण कार्यों का निष्पादन

राजभाषा अधिनियम की धारा 3 (3) के अंतर्गत यथापेक्षित द्विभाषी रूप से जारी किए जाने वाले कागजातों, ब्यूरों के विभिन्न पदों के भर्ती नियमों, कार्यालय आदेशों, मानक प्रपत्रों आदि का हिंदी रूपातर उपलब्ध कराया गया ।

इसके अतिरिक्त, गृह मंत्रालय से संबंधित विभिन्न प्रकार की सामग्री का हिंदी अनुवाद भी उपलब्ध कराया गया। ब्यूरो मुख्यालय की वेबसाइट हेत् अंग्रेजी से हिंदी अनुवाद किया गया।

भारत सरकार के राजभाषा विभाग द्वारा निर्धारित लक्ष्यों और केंद्र सरकार की राजभाषा नीति के अनुसरण में ब्यूरो मुख्यालय एवं इसके क्षेत्रीय कार्यालयों में कार्यान्वयन तथा अनुवाद संबंधी सभी अपेक्षित कार्यों को समयबद्ध संपन्न किया गया।

विश्वपटल पर उभरती हिंदी भाषा

कह सकू किसी से दो शब्द कभी, मन में जब भी अभिलाषा होती है तो सबसे पहले मन के अंदर, मेरी मातृभाषा ही होती है

भाषा का प्रादुर्भावः-

हम जैसे ही जन्म लेते हैं, सर्वप्रथम रोते हैं और हमारे रोने की ध्विन के साथ ही हमारी माँ को इस बात से सुकून मिलता है कि मेरा बच्चा स्वस्थ है, फिर हमारी संवेदनाएं अपनी माँ के आँचल में पलकर मूक दर्शन से धीरे—धीरे एक गुमनाम सफर तय करना शुरू करती हैं। उस सफर के दौरान हम कभी बिना कुछ बोले तो कभी कुछ आवाज के साथ अपनी निजी संवेदनाओं को व्यक्त करते हैं और इसी क्रम में किलकारियों के साथ शनैः शनैः भाषा का प्रादुर्भाव होता है।

भाषा के विकास के प्रथम चरण में माँ अपने उन्मुक्त कठ से कभी अपने बच्चों को तरह—तरह की प्रतिध्वनियों से अभिशिप्त करती है, कभी पुचकारती है तो कभी लोरी सुनाती है, तो बालक भी अपनी किलकारियों से शनैः शनैः उनका उत्तर देना प्रारंभ करता है। धीरे—धीरे वह अपनी माँ की ध्वनियों का हू—ब—हू अनुकरण करने लगता है और इसी क्रम में जिस ध्वनियों से बोली और भाषा से मानव चिर—परिचित होता है, उस नाद, उस ध्वनि उसी भाषा को हम अपनी मातृभाषा के रुप में स्वीकार कर लेते हैं। कुल मिलाकर हम कह सकते हैं कि अपनी अभिव्यक्तियों को व्यक्त करने के प्रथम माध्यम को ही मातृभाषा के रुप में हृदय से अगीकृत करते हैं।

भाषाओं की विविधताः

हमारे देश का क्षेत्रफल 32,87,263 वर्ग कि.मी. है, जिसमें भौगोलिक विविधता के साथ कश्मीर से कन्या कुमारी तक और कच्छ से कोहिमा (कामरुप) तक विभिन्न कद—काठी और भेष—भूषा के साथ अनेक संस्कृतियाँ एक सूत्र में पिरोकर चलती हैं। इस विभिन्नता के महादेश में भाषा में विभिन्नता होना तो नितांत स्वाभाविक है। शायद इसीलिए हमारे देश में भाषा की विविधता को लेकर एक मुहावरा बहुत ही प्रसिद्ध है कि "कोस—कोस पर पानी बदले, चार कोस पर वाणी"।

एकता की द्योतक बनी हिंदी

जैसे किसी एक परिवार को संयुक्त रखने के लिए माँ की भूमिका बहुत ही महत्वपूर्ण होती है ठीक कुछ उसी प्रकार अगर संपूर्ण भारतवर्ष को एक भाषा के सूत्र में पिरोने को कहा जाए तो स्वतंत्रता संग्राम के पूर्व से ही हिंदी भाषा का बोल—बाला कुछ इस कदर था कि स्वतंत्रता आंदोलन में हिंदी साहित्य का इतिहास अपने स्वर्णिम उत्कर्ष पर था, क्रांतिकारी स्लोगन और क्रांतिकारियों के संगठन को शक्तिशाली बनाने में हिंदी एक अहम कड़ी थी, यही कारण था कि देश के विभिन्न अहिंदीभाषी क्षेत्रों के क्रांतिकारियों ने भी हिंदी भाषा को सहर्ष स्वीकार किया था।

हिंदी और स्वतंत्रता संग्राम

नेता जी सुभाष चंद्र बोस जी द्वारा हिंदी भाषा में स्लोगन दिया गया था "तुम मुझे खून दो, मैं तुम्हें आजादी दूंगा" जो आज भी स्वर्णिम अक्षरों में जीवंत है। महात्मा गांधी, तांत्या टोपे, सरदार बल्लम भाई पटेल, महाराणा प्रताप, भगत सिंह जैसे अनेक महान क्रांतिकारी योद्धाओं ने अहिंदीभाषी होते हुए राष्ट्र को सर्वोपरि मानते हुए अपनी मातृभाषा में जो कुछ भी शब्द स्वतंत्रता आंदोलन में प्रयोग किये, उनके एक—एक स्लोगन दिव्यास्त्र स्वरुप बनते चले गये।

हिंदी भाषा को संवैधानिक मान्यताः

भारत की आजादी के पहले यह एक बड़ा मुद्दा था कि आजाद भारत की राष्ट्रीय भाषा क्या होगी? हमारे देश को तोड़ने के लिए जाति—धर्म, काले—गोरे, छूत—अछूत अनके कारणों के साथ—साथ, भाषा को भी एक अहम मुद्दा बनाया जा रहा था। कुल मिलाकर अंग्रेज और मुगल शासक कभी नहीं चाहते थे कि हम एक हो सके, हमें हर प्रकार से अलग करना उनका लक्ष्य होता था। लेकिन आजादी के महानायक, सत्य एवं अहिंसा का मार्ग प्रशस्त



करने के साथ ही महात्मा गांधी ने ब्रिटेन दौरे से लौटने के बाद सन 1918 में इंदौर स्थित एक सम्मेलन में यह कहा था कि "जैसे ब्रिटिश अंग्रेजी में बोलते हैं और अपने सारे काम अंग्रेजी में करते हैं. वैसे ही मैं प्रार्थना करता हँ कि भारतवर्ष में हिंदी को स्वतंत्रता के बाद "राष्ट्रभाषा" का सम्मान दिया जाएगा" इसे राष्ट्रभाषा बनाकर हमें अपने कर्तव्यों को निभाना चाहिए। 15 अगस्त, 1947 को हमारा देश स्वतंत्र हुआ और संविधान सभा में 14 सितंबर, 1949 को हिंदी को राजभाषा का दर्जा प्राप्त हुआ।

हिंदी भाषा के बढ़ते कदमः

सदियों तक की दासता ने ना सिर्फ हमारी संस्कृतियों को प्रभावित किया अपित हमारे संस्कार, साहित्य और भाषा को भी बहुत बुरी तरह से प्रभावित किया था और अब समय था हमारे पुनः एकजुट होने का, जिसके लिए स्वतंत्रता के उपरांत सभी राज्यों को उनके स्थानीय भाषा में राजकीय कार्य प्रारंभ करने की योजना बनाई गई और हिंदी को राष्ट्रीय भाषा के तौर पर विकसित करने का संकल्प लिया गया और यहीं से शुरु हुआ हमारी मातृभाषा के विकास का वास्तविक और संवैधानिक स्वरुप।

वर्तमाम समय में हिंदी का उपयोगः

आज हमारे देश की स्वतंत्रता के 75 वर्ष पूर्ण हो चुके हैं और जब हम भारतवर्ष में आजादी का अमृत महोत्सव मना रहे हैं तो विश्व के सर्वाधिक लोकप्रिय, यशस्वी, प्रधानमंत्री के तौर पर श्री नरेन्द्र भाई मोदी जी के विचारों को सुनने के लिए ना सिर्फ भारतवर्ष के सवा सौ करोड भारतवासी अपित विश्व के अन्य देशों से करोड़ों लोग कप्यटर, मोबाइल, टेलीविजन, इंटरनेट आदि के माध्यम से हिंदी भाषा का उपयोग करते हैं। भारत समेत विश्व के अनेक सरकारी एवं गैर सरकारी कार्यालयों में, बैंकिंग सुविधाओं के लिए, पैसों के स्थानांतरण के लिए, विज्ञापन के लिए, रोजगार के लिए, साहित्य लेखन के लिए, हिंदी मूवी के बड़े पर्दे सहित अनेक छोटे-छोटे सीरियल के लिए, सोशल मीडिया पर अपनी बातों को अधिक से अधिक जन-मानस तक शीघ्रता से पहुंचाने के लिए, लोग हिंदी को अपना रहे हैं। अनेकानेक सॉफ्टवेयर के माध्यम से अलग-अलग क्षेत्रों में लोग हिंदी भाषा का उपयोग कर रहे हैं। भारत सहित विश्व पटल पर एक विशाल जनसमूह हिंदी को अपना अभिन्न अंग बनाकर इस बात को स्वीकार कर रहा हैं कि आज विश्व को हिंदी की जरुरत है।

निष्कर्षः-

संघर्षों के समय जिस तरह हमारी माँ, हमारा साथ कभी नहीं छोड़ती है ठीक उसी प्रकार हिंदी हमारी मातृभाषा है, स्वतंत्रता के संग्राम से लेकर आज तक हमारी मातृभाषा अपनी मृद्लता, सरलता, सहजता के भाव से ना सिर्फ इस देश को अपित सम्पूर्ण विश्व को एकता के सूत्र में जोड़ने के लिए उपयोग हो रही है। इसलिए हमें हिंदी को न सिर्फ राजभाषा के तौर पर अपने कामकाज की भाषा तक सीमित रखना चाहिए अपितू हिंदी को अपनी मातृभाषा के रुप में आत्मसात करना चाहिए, जिससे हमारी संस्कृति, राष्ट्रभाषा और राष्ट्र का गौरव सदैव गौरवान्वित होता रहे और विश्वपटल पर हिंदी के साथ-साथ हिंदुस्तान का कीर्ति-पताका सदैव फहराता रहे।


