New Delhi, the 17th May, 2018

- **G. S. R 482(E).**—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules to amend the Ministry of Home Affairs, Narcotics Control Bureau, Staff Car Driver (Special Grade) (Group 'B' Non Gazetted post) Recruitment Rules, 2015, namely:-
- 1. (1) These rules may be called the Ministry of Home Affairs, Narcotics Control Bureau, Staff Car Driver (Special Grade) (Group 'B' Non Gazetted post) Recruitment (Amendment) Rules, 2018.
 - (2) They shall come into force on the date of its publication in the Official Gazette.
- 2.In the Ministry of Home Affairs, Narcotics Control Bureau, Staff Car Driver (Special Grade) (Group 'B' Non Gazetted post) Recruitment Rules, 2015 (hereinafter referred to as the said rules), for rule 2, the following rule shall be substituted, namely:-
 - "2. Number of post, classification and level in the pay matrix.- The number of post, its classification and level in the pay matrix attached thereto, shall be as specified in column(2) to (4) of the Schedule annexed to these rules."
- 3. In the said rules, in the Schedule,-
 - (A) in column (2), for the figures and bracket "04*(2015)", the figures and bracket "05*(2018)" shall be substituted;
 - (B) In column (4), for the heading and the entries relating thereto, the following shall be substituted, namely:-

"Level in the pay matrix

- (C) in column (11), under sub-heading "Promotion",-
 - (i) for the words, figures and letters "pay band-1, Rs. 5200-20200 with grade pay of Rs. 2800", the words, figures and letters "level-5 (Rs. 29200-92300/-)" shall be substituted.
 - (ii) Note 2 shall be omitted.

- G.S.R. 903(E).—In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Ministry of Home Affairs (Narcotics Control Bureau) Group 'C' and Group 'D' Posts, Recruitment Rules 2007, in so far as it relates to the post of Staff Car Driver (Special Grade) except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Staff Car Driver (Special Grade), in the Narcotics Control Bureau, Minstry of Home Affairs, namely:-
- 1. Short title and commencement.—(1) These rules may be called the Ministry of Home Affairs, Narcotics Control Bureau, Staff Car Driver (Special Grade) (Group 'B' Non Gazetted post) Recruitment Rules, 2015.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Number of posts, classification, pay band and grade pay or pay scale.—The number of the posts, its classification, pay band and grade pay or pay scale attached thereto shall be as specified in columns (2) to (4) of the said Schedule annexed to these rules.
- 3. Method of recruitment, age limit and other qualifications, etc.—The method of recruitment to the said post, age limit, qualifications and other matters relating thereto, shall be as specified in columns (5) to (13) of the aforesaid Schedule.
- 4. **Disqualification.** No person,—
 - (a) who has entered into or contracted a marriage with a person having a spouse living; or
 - (b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. Power to relax.—Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.
- **6.** Saving.—Nothing in these rules shall affect reservation, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Other Backward Classes, Exservicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
