MINISTRY OF HOME AFFAIRS NOTIFICATION

New Delhi, the 12th September, 2023

G.S.R. 695(E).--In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules to amend the Ministry of Home Affairs, Narcotics Control Bureau (Havaldar) Recruitment Rules, 2018, namely:-

- 1. Short title and commencement.— (1) These rules may be called the Ministry of Home Affairs, Narcotics Control Bureau (Havaldar) Recruitment (Amendment) Rules, 2023.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. In the Ministry of Home Affairs, Narcotics Control Bureau (Havaldar) Recruitment Rules, 2018, in the Schedule,-
 - (i) in column(2), for the figures "51", the figures "68" shall be substituted;
 - (ii)in column (12), at serial number (3), for the entry "Assistant Director, Central Para Military Force-Member" the entry "Assistant Commandant, Central Armed Police Force-Member" shall be substituted.

MINISTRY OF HOME AFFAIRS NOTIFICATION

New Delhi, the 19th June, 2018

G.S.R. 580(E).— In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Ministry of Home Affairs, Narcotics Control Bureau Havaldar (Group 'C') post, Recruitment Rules, 2010, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Havaldar in the Narcotics Control Bureau under the Ministry of Home Affairs, namely:-

- 1. Short title and commencement.— (1) These rules may be called the Ministry of Home Affairs, Narcotics Control Bureau (Havaldar) Recruitment Rules, 2018.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Number of post, classification and level in the pay matrix.— The number of post, its classification and the level in the pay matrix attached thereto, shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- 3. **Method of recruitment, age-limit and qualifications, etc.** The method of recruitment, age-limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (13) of the aforesaid Schedule.
- 4. Disqualification.— No person,-
 - (a) who has entered into or contracted a marriage with a person having a spouse living; or
 - (b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. **Power to relax.** Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 6. **Saving.** Nothing in these rules shall affect reservation, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Other Backward Classes, the Ex-Servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
