- G.S.R. 19.—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules regulating the method of recruitment to the post of Office Superintendent in the Narcotics Control Bureau, under the Ministry of Home Affairs, namely:-
- 1. Short title and commencement.—(1) These rules may be called the Ministry of Home Affairs, Narcotics Control Bureau, Office Superintendent (Group 'B' Post) Recruitment Rules, 2025.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Number of post, classification and level in pay matrix. The number of the said post, its classification and level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- 3. Method of recruitment, age-limit, qualifications, etc.— The method of recruitment, age-limit, qualifications and other matters relating to the said post shall be as specified in columns (5) to (13) of the said Schedule.
- 4. Disqualification. No person,-
 - (a) who has entered into or contracted a marriage with a person having a spouse living; or
 - (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. Initial constitution. The persons holding the post mentioned in the Schedule on the date of commencement of these rules on regular basis shall be deemed to have been appointed under these rules and the service rendered by them in the said post on regular basis before the said commencement shall be taken into account for deciding their period of probation, seniority, pensionary benefits and eligibility for promotion to the next higher grade.
- 6. Power to relax. Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.
- 7. Saving. Nothing in these rules shall affect reservation, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Other Backward Classes, the

Ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

Deputation: Officers of the Central Government or State Governments or Union territory Administrations, - (a) (i) holding analogous posts on a regular basis in the

parent cadre or department; or

- (ii) with two years service after appointment to the posts on a regular basis in level-7 in the pay matrix (Rs. 44900-142400) or equivalent in the parent cadre or department; and
- (b) possessing the following educational qualifications and experience, namely:-
- (i) Bachelor's degree from a recognised university or institute;
- (ii) Two years experience in Administration or Establishment and Accounts work.
- Note 1.- The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, the deputationists shall not be eligible for consideration for appointment by promotion.
- Note 2.- The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not exceed three years.
- **Note 3.-** The maximum age-limit for appointment by deputation shall be not exceeding fifty-six years as on the last date of receipt of applications.

सा.का.िन. 20.— राष्ट्रपति, संविधान के अनुच्छेद 309 के परंतुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए और गृह मंत्रालय, पुलिस अनुसंधान एवं विकास ब्यूरो, प्रवर श्रेणी लिपिक, भर्ती नियम, 2023 को, उन बातों के सिवाय अधिक्रांत करते हुए, जिन्हें ऐसे अधिक्रमण से पहले किया गया है या करने से लोप किया गया है, गृह मंत्रालय, पुलिस अनुसंधान एवं विकास ब्यूरो में प्रवर श्रेणी लिपिक के पद पर भर्ती की पद्धित का विनियमन करने के लिए निम्नलिखित नियम बनाते हैं, अर्थातः -

- 1. **संक्षिप्त नाम और प्रारंभः-** (i) इन नियमों का संक्षिप्त नाम गृह मंत्रालय, पुलिस अनुसंधान एवं विकास ब्यूरो, प्रवर श्रेणी लिपिक (समूह 'ग' पद), भर्ती नियम, 2024 है।
 - (ii) ये राजपत्र में इनके प्रकाशन की तारीख को प्रवृत्त होंगे।
- 2. **पद की संख्या, वर्गीकरण और वेतन मैट्रिक्स में स्तर** उक्त पद की संख्या, उसका वर्गीकरण और वेतन-मैट्रिक्स में उसका स्तर वह होगा, जो इन नियमों से उपाबद्ध अनुसूची के स्तंभ (2) से स्तंभ (4) में विनिर्दिष्ट हैं।
- 3. भर्ती की पद्धित, आयु-सीमा और अर्हताएं, आदि:- भर्ती की पद्धित, आयु-सीमा, अर्हताएं और उनसे संबंधित अन्य बातें वे होंगी जो उक्त अनुसूची के स्तंभ (5) से स्तंभ (13) में विनिर्दिष्ट हैं।
- निरर्हता- वह व्यक्ति -
 - (क) जिसने किसी ऐसे व्यक्ति से, जिसका पित या जिसकी पत्नी जीवित है, विवाह किया है या विवाह की संविदा की है, या
