New Delhi, the 14th August, 2023

G.S.R. 694(E).-- In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules to amend the Ministry of Home Affairs, Narcotics Control Bureau (Junior Intelligence Officer) Group 'B' post Recruitment Rules, 2022, namely:--

- Short title and commencement.— (1) These rules may be called the Ministry of Home Affairs, Narcotics Control Bureau (Junior Intelligence Officer) Group 'B' post Recruitment (Amendment) Rules, 2023.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- In the Ministry of Home Affairs, Narcotics Control Bureau (Junior Intelligence Officer) Group 'B' post Recruitment Rules 2022 (hereinafter referred to as the said Rules),--
 - in the opening paragraph, for the words "Junior Intelligence Officer", the words "Sub-Inspector" shall be substituted;
 - iii) in rule1, in sub-rule(1), for the brackets and words "(Junior Intelligence Officer)", the brackets and words "(Sub-Inspector)" shall be substituted;
 - (iii) in the schedule,--
 - (a) in column(1), for the words "Junior Intelligence Officer", the words "Sub-Inspector" shall be substituted;
 - (b) in column(2), for the figures and brackets "195*(2022)", the figures and brackets "295*(2023)" shall be substituted.

- G.S.R. 444(E).—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules regulating the method of recruitment to the post of Junior Intelligence Officer in the Narcotics Control Bureau under the Ministry of Home Affairs, namely:-
- 1. Short title and commencement.— (1) These rules may be called the Ministry of Home Affairs, Narcotics Control Bureau (Junior Intelligence Officer) Group 'B' post Recruitment Rules, 2022.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Number of posts, classification and level in the pay matrix. The number of posts, its classification and level in the pay matrix attached thereto, shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- 3. Method of recruitment, age-limit and other qualifications, etc.- The method of recruitment, age-limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (13) of the aforesaid Schedule.
- 4. Disqualification.- No person,-
 - (a) who has entered into or contracted a marriage with a person having a spouse living; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. Initial Constitution.- The persons holding the post mentioned in the Schedule on the date of commencement of these rules on regular basis shall be deemed to have been appointed under these rules and the service rendered by them in the said post on regular basis before the said commencement shall be taken into account for deciding their period of probation, seniority, pensionary benefits and eligibility for promotion to the next higher grade.
- 6. Power to relax.- Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing, and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.
- 7. Saving.- Nothing in these rules shall affect reservation, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Other Backward Classes, the Ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

Note 2: The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organisation or Department of the Central Government shall ordinarily not to exceed three years. Note 3: The maximum age-limit for appointment by deputation shall not be exceeding fifty-six years as on the closing date of receipt of applications. Limited Departmental Competitive Examination (LDCE):- The departmental Sepoy in level-1 (Rs. 18000-56900/-) of the pay matrix, Havaldar in level-1 of the pay matrix and Surveillance Assistant in level-4 (Rs. 25500-81100/-) of the pay matrix of Narcotics Control Bureau having,- (i) Bachelor degree from a recognised university or institution; (ii) eleven years' regular service rendered in the grade in level-1 for Sepoy or Havaldar of Narcotics Control Bureau; (iii) six years regular service rendered in the grade in level-4 for Surveillance Assistant; (iv) Physical standard as mentioned in Column (7) for direct recruitment.
