MINISTRY OF HOME AFFAIRS NOTIFICATION

New Delhi, the 17th May, 2018

G.S.R. 483(E).— In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules to amend the Ministry of Home Affairs, Narcotics Control Bureau, Section Officer (Group 'B' Gazetted post) Recruitment Rules, 2015 namely:—

- (1) These rules may be called the Ministry of Home Affairs, Narcotics Control Bureau, Section Officer (Group 'B' Gazetted post) Recruitment (Amendment) Rules, 2018.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. In the Ministry of Home Affairs, Narcotics Control Bureau, Section Officer (Group 'B' Gazetted post) Recruitment Rules, 2015 (hereinafter referred to as the said rules), for rule 2, the following rule shall be substituted, namely:—
 - "2. Number of post, classification and level in the pay matrix.—The number of post, its classification and level in the pay matrix attached thereto, shall be as specified in column(2) to (4) of the Schedule annexed to these rules."
- 3. In the said rules, in the Schedule,—
 - (A) In column (4), for the heading and the entries relating thereto, the following shall be substituted, namely:—

"Level in the pay matrix

(B) In column (11),—

(I) Under sub-heading "Promotion",-

- for the words, figures and letters "Pay Band-2: Rs.9300-34800 with grade pay of Rs. 4200", the words, figures and letters "Level-6 (Rs. 35400-112400/-)" shall be substituted;
- (ii) Note 2 shall be omitted;
- (II) under the sub-heading "Deputation including short term contract",—
 - (i) in item (a), in sub-item (ii), for the words, figures and letters "Pay Band-2: Rs. 9300-34800/- with grade pay of Rs. 4200", the words, figures and letters "Level-6 (Rs. 35400-112400/-)" shall be substituted;
 - (ii) Note 4 shall be omitted.

NOTIFICATION

New Delhi, the 3rd December, 2015

G.S.R. 930(E).—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules regulating the method of recruitment to the post of Section Officer, in the Narcotics Control Bureau, Ministry of Home Affairs, namely:-

- 1. Short title and commencement.—(1) These rules may be called the Ministry of Home Affairs, Narcotics Control Bureau, Section Officer (Group 'B' Gazetted post) Recruitment Rules, 2015.
 - (2) They shall come into force on the date of their publication in the Official Gazette.

- 2. Number of posts, classification, pay band and grade pay or pay scale.—The number of the posts, its classification, pay band and grade pay or pay scale attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- 3. **Method of recruitment, age limit and other qualifications, etc.**—The method of recruitment to the said post, age limit, qualifications and other matters relating thereto, shall be as specified in columns (5) to (13) of the said Schedule.
- 4. **Disqualification.**—No person,—
 - (a) who has entered into or contracted a marriage with a person having a spouse living; or
 - (b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. **Power to relax.—** Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing and in consultation with the Union Public Service Commission relax any of the provisions of these rules with respect to any class or category of persons.
- 6. **Saving.**—Nothing in these rules shall affect reservation, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Schedule Tribes, Other Backward Classes, Ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time-to-time in this regard.

promotion, their seniors would also be considered provided they are not short of the requisite qualifying or eligibility service by more than half of such qualifying or eligibility service or two years, which ever is less, and have successfully completed their probation period for promotion to the next higher grade alongwith their juniors who have already completed such qualifying or eligibility service.

Note 2: For the purpose of computing minimum qualifying service for promotion, the service rendered on a regular basis by an officer prior to the 1st January, 2006 or the date from which the revised pay structure based on the recommendations of the 6th Central Pay Commission has been extended, shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the said Pay Commission.

Deputation including short term contract:

Officers of the Central Government or State Governments or Union Territories or Autonomous Bodies or Public Sector Under takings or statutory bodies or recognised research institutions or Universities or semi-government organisations:

- (i) holding analogous posts on regular basis in the parent cadre or department; or
 (ii) with five years service in the grade rendered.
 - (ii) with five years service in the grade rendered after appointment thereto on regular basis in the pay band-2, Rs.9300-34800 with grade pay of Rs.4200/-, or equivalent in the parent cadre or department; and
- (b) possessing the following educational qualification and experience:
 - (i) Bachelor's degree from any of the Universities incorporated by an Act of Parliament or State Legislature or other educational institutions established by an Act of Parliament or declared to be a deemed University under the University Grant Commission Act, 1956; and
 - (ii) Two years work experience in accounts or administration or establishment matters.

Note 1: The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation or absorption. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Note 2: The period of deputation (including short term contract) including period of deputation (including short term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or Department of the Central Government shall ordinarily not to exceed three years.

Note 3: The maximum age limit for appointment by deputation (including short term contract) shall not to exceeding 56 years as on the closing date of receipt of applications.

Note 4: For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to the 1st January, 2006 or the date from which the revised pay structure based on the recommendations of the 6th Central Pay Commission has been extended, shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based
