NOTICE FOR APPLICATION

Applications are invited for appointments of advocates as Senior Public Prosecutor to represent the office of the DDG(WR), NCB, Ahmedabad and Public Prosecutor to represent the office of Ahmedabad Zonal Unit, NCB, Ahmedabad on a contract basis.

Details of eligibility criteria and other terms and conditions

1. Eligibility Criteria:

	Senior Public Prosecutor (Sr. PP)	Advocates with experience of ten years or more at the Bar.
b)	Public Prosecutor (PP)	Advocates with experience of seven years or more at the Bar.

2. Nature of Duties:

The candidates appointed as Senior Public Prosecutor and Public Prosecutor shall be required prosecute the court cases of NCB, provide legal advice on investigation when the enquiry/investigation is underway, guide to improve the quality of evidence to be gathered during investigation, develop expertise in presenting the case for prosecution, monitor the progress of trial, submit court diaries and perform such other duties of legal nature, which may be assigned by the NCB.

3. Place of Work, Vacancies and emoluments:

- I. A total of 01 vacancies for Senior PP are available. (01 vacancy available at O/o the DDG (WR), NCB, Ahmedabad.)
- The Senior Public Prosecutor (Sr. PP) will draw a payment of Rs. 100000/-11. (Rs. One Lakh Only) per month (consolidated). No additional allowances viz. HRA, Medical, LTC, except TA/DA as per entitlement, shall be paid.
- A total of 01 vacancies for PP are available. (01 vacancy available at O/o the III. Additional Director, NCB, Ahmedabad Zonal Unit.)
- IV. The Public Prosecutor (PP) will draw a payment of Rs. 80,000/- (Rs. Eighty thousand only) per month (consolidated). No additional allowances viz. HRA, Medical, LTC, except TA/DA as per entitlement, shall be paid.

4. Terms and Conditions:

- I. The tenure for the appointment of Sr. PP and PP shall be for 03 years or till the appointment of a regular Sr. PP/PP, whichever is earlier.
- The Sr. PP and PP, on having accepted the offer of appointment, shall enter П. into a Contract, having the confidentiality clause, integrity clause, and noncompete clause with the Narcotics Control Bureau.
- Any breach of Contract by the Sr. PP or PP with the NCB shall be considered III. a sufficient ground for termination of the contract.
- The Sr. PP and PP shall not be allowed to engage in private practice. IV.
- V. Notwithstanding anything contained herein above, the NCB and/or the Counsel may terminate the appointment with one month's advance notice.
- Sr. PP and PP will, from immediate effect, hand over the charge/records to the VI. successor on the expiry/ termination of the contract.

5. Selection Process:

Only shortlisted candidates will be called for the further selection process individually. An intimation in this regard shall be sent to their registered email ID and through telephone. No TA/DA will be paid to candidates for appearing at the interaction. On completion of the selection process, information shall be sent to the selected candidates through e-mail and telephone.
